

## **NZ Promotional Terms & Conditions – Paslode PPN-Master™ Instant Giveaway 2026**

### **1. Introduction**

1.1 These Terms and Conditions apply to the Paslode Impulse PPN-Master™ Positive Placement Nailer promotion (“Promotion”) conducted by ITW New Zealand Limited.

1.2 Entry into the competition (as detailed below) is deemed to be acceptance of these terms and conditions.

### **2. Eligibility**

2.1 This competition is open to all New Zealand residents who are 18 years of age or older (“entrant”).

### **3. Participating Stores and Promotional Period**

3.1 The Promotion commences 1 February 2026 and ends 31 March 2026 inclusive (“Promotional Period”).

3.2 Participating stores are authorised Bunnings retailers in New Zealand that advertise or display this Promotion during the Promotional Period.

### **4. How to Participate**

4.1 To qualify, participants must purchase one (1) Paslode Impulse PPN-Master™ Positive Placement Nailer (Product Code B60001) (“Qualifying Product”) in-store at a participating Bunnings during the Promotional Period, while stocks last.

4.2 Each Qualifying Product purchased entitles the purchaser to receive an instant prize as set out below.

4.3 Multiple purchases in a single transaction qualify for multiple instant prizes.
